

Privacy Policy

Our Commitment to Protect Your Privacy

We understand how important it is to protect your personal information. This document sets out our Privacy Policy commitment in respect of personal information that you may provide to us.

Our Privacy Policy ensures your right to privacy as we recognise that any personal information, we may collect about you will only be used for the purposes indicated in our Policy. What does CommShare do?

CommShare promotes shared ownership of Commercial and Industrial Real Estate. From time to time, we provide prospective investors/purchasers with notification advising of tenant-in-common shares of ownership in real estate offers that become available for investment.

Personal Information

When we refer to “personal information”, we mean information from which your identity is apparent.

Why We Collect Your Personal Information

We collect and receive personal information to conduct our business. To enable us to maintain a successful business relationship with you, we may disclose your personal information to another person or organisation that may have or is considering taking up an ownership interest in your property investment offer.

How Do We Collect Your Personal Information?

Where reasonable and practical, we will collect your personal information only directly from you.

To Whom Will We Disclose Your Personal Information?

Where possible, we will inform you, at or before the time of collecting your personal information, the types of organisations that we intend to disclose your personal information to. Prior to disclosing any of your personal information to another organisation, we will take all reasonable steps to satisfy ourselves that:

- a. the organisation has a commitment to protecting your personal information at least equal to our commitment; and
- b. you have consented to us doing so.

Direct Marketing

From time to time, we may use your personal information to provide you with information about changes to our organisation or new products or services being offered by us, or any company we are associated with.

Updating Your Personal Information

It is important to our relationship that the personal information we hold about you is accurate and up to date. During our relationship, we may ask you to inform us if any of your personal information has changed.

If you wish to make any changes to your personal information, you may contact us. We will generally rely on you to assist us in informing us if the information we hold about you is inaccurate or incomplete.

Access to Your Personal Information

How Safe and Secure is Your Personal Information Held by us?

We will also take reasonable steps to protect any personal information from misuse, loss and unauthorised access, modification, or disclosure.
